All players.....

- Must respect the rights and dignity and worth of all club members and supporters and treat them each equally regardless of age gender or ability.
- Always show respect to Team Manager and under no circumstance abuse his/her position. Never use foul or provocative language to another player or match official on or off the field of play. (club or opposition)
- You are not permitted to shout or lecture to another player during a match/ dressing room or public place or reprimand/ridicule him or her for poor performance or mistake whilst playing in a match or in practice.
- At all times respect fellow players, referee or match officials and opponents during a match, you must set high standards and not bring the club into disrepute with County Board or the law.
- You must not act towards or speak to another person from your club or any other club in a manner or engage in any other conduct which threatens, disparages, vilifies, or insult another person on the basis of that person's race, religion, colour, descent, nationality, ethnicity or socio economic background.
- Must pay their yearly Club Membership and Insurance by the stated deadline and no player can engage the services of a physiotherapist without the consent of Team Manager or Club Chairman. Each player must always observe a high level of personnel hygiene and is responsible to return team jersey and other gear supplied by the club for games and practice.
- As a registered player you are expected to inform yourself of the club's training schedule and match fixtures and you must liaise with the Team Mgr. at all times regards your future commitments and availability. All team selections are made by the Team Manager and his/her Selectors.
- Are asked by the club to build camaraderie and friendship. All players are encouraged to settle any differences with a fellow Gael be it a player or any other club member.

#### **Who is Servasport Limited?**

Servasport Limited is a "data processor" who hosts the database on which your information is stored. We have a contract in place with Servasport Limited to ensure your Personal Data is stored safely and securely.

#### **How long will your Personal Data be stored for?**

Your Personal Data will be held for the duration of your Membership and it will be deleted by us in the event that you resign your Membership or you are expelled in accordance with the Official Guide. However we may retain your Personal Data after your Membership ceases if we decide that it is strictly necessary to do so in the circumstances in accordance with our data retention policy.

#### **How can I obtain a copy of the Personal Data held by the Club/GAA?**
